Terms & Conditions

The Watershed District shall:

1. Order trees

The Applicant shall:

- 1. Pick up trees
- 2. Plant trees
- 3. Remit payment for trees in a timely manner.
- AWWD does not provide warranty on tree seedlings
- Orders for trees are taken up until the deadline April 1st. Full payment must accompany the application. Cash, cheques or e transfers are accepted.
- No change in orders or refunds are considered once the order has been placed by the IMWD with our tree supplier. Due to the nature of the tree nursery business there may be instances where the IMWD is unable to supply the order requested. In these instances, the purchaser can either take a substitution of stock of equal value or a refund. Orders are filled on a first come first serve basis.
- Tree seedlings are expected to be received between May 1st and May 1sth. Seedling pickup
 dates will be determined by the IMWD and all applicants will be notified. Pick up is at the
 Miniota AWWD office.
- Any seedlings purchased but not picked up on the pickup dates, will revert to the property of the IMWD unless prior arrangements have been made. No refunds will be issued.
- Tree species subject to supplier availability and import restrictions.
- Subject to the above terms, the agreement shall become effective and shall be binding upon both parties.
- If either party fails to meet the above mentioned responsibilities, the agreement may be terminated by the party via written notice.
- The annual projects resulting from this program will be subject to funds appropriated.
- Technical service will be subject to the availability of staff. The district reserves the right to establish priorities for providing such services and assistance.
- Failure of Landowner to meet Landowner Responsibilities may negate him/her from other Watershed District programs.
